By giving the Undertaking and placing my/our signature(s) hereto, I/we understand and acknowledge that the appointments of Private Property Officers are strictly for the purpose of ticketing unauthorized vehicles only and the said appointments in no way permit, allow or authorize me/we or any of the persons appointed as Private Property Officers to tow unauthorized vehicles. I/we understand and agree that deletion from the list or Private Property Officers can occur for improper use of the City of Ottawa's Parking Infraction Notices, failure to appear in court when required, failure to adhere to the rules and regulations of the Private Property Parking Enforcement Program of the City, complaints as to improper conduct or where, in the opinion of the City, it is in the interest to make such deletions.
