On July 17, 2015, I became aware that the audited Form 4 Financial Statement for my campaign contained an arithmetic error. In Box D: Calculation of Surplus or Deficit, on the line to 'deduct any refund of candidate's or spouse's contributions to the campaign', the \$6,620 figure presented reflected the total contributions to the campaign from the candidate and his spouse, not the total actually refunded at the conclusion of the campaign.

The attached revised Form 4 Financial Statement correctly reflects on that line the actual amount refunded by the campaign of \$89.18. The resulting surplus (deficit) for the campaign in nil. I believe this to be in accordance with the Municipal Elections Act, 1996, paragraph 79 (6).

The auditor has acknowledged this change via their reissued reported dated June 18, 2015, which is also attached.
