

2025 Tree Equity Scores by Transect

Below are tables that have details on 2025 Tree Equity Scores for each census tract by urban transect. Some census tracts span multiple transects and may have different scores. If you are unsure about your census tract and transect, please check the Tree Equity Scores by transect maps on [geoOttawa](#). Tree Equity Score data for each transect is also available for download on Open Ottawa: [Downtown Core](#), [Inner Urban](#), [Outer Urban](#), and [Suburban](#). Census tracts that have been identified as one of the eight **Priority Areas** are highlighted. Census tracts that are one of the areas identified for **short-term action are bolded**. More information on the Tree Equity Score methodology can be found on the City of Ottawa website. The definitions for each column are:

Census Tract Number: The identification number assigned to the census tract by the 2021 Canadian Census of the Population.

Census Tract Name: Common neighbourhood names created by the City of Ottawa's [Neighbourhood Equity Index](#).

Canopy Cover (%): Canopy cover area within the census tract, as a per cent of census tract area.

Canopy Goal (%): Transect-level canopy cover goal based on building density.

Canopy Gap: The difference between the canopy goal (%) and actual canopy cover (%). This represents the per cent area of the census tract that could be planted to reach the canopy goal.

Gap Score: The normalized canopy gap for each census tract, based on the maximum canopy gap of the transect.

Priority Index: Index of seven, equally weighted demographic, socio-economic, health, and urban heat indicators.

Tree Equity Score: Census tract score ranging from 0-100 that highlights inequitable access to trees. A lower score indicates a greater need for tree planting. A score of 100 indicates that the census tract has enough tree canopy cover to meet the needs of the neighbourhood residents.

Transect: Official plan urban transect the census tract falls within.

Note: Details on exemptions or special considerations for the census tract.
