## Notes:

- 1. Under the ESA 2007, endangered and threatened species and their habitat are protected. The MNR is responsible for developing regulations for each species to identify areas or types of habitat to be protected. In the absence of specific habitat regulations, the habitat features on which members of the species currently depend are protected as general habitat for the species.
- 2. SARA provisions only apply to species listed on Schedule 1 (Schedules 2 and 3 list species awaiting reassessment by COSEWIC, which will then be promoted to Schedule 1 if they are determined to still be at risk). Endangered and threatened species on Schedule 1, and their residences, are protected. This protection only extends to species under federal jurisdiction, such as migratory birds or aquatic species, or to species occurring on federal lands such as the NCC Greenbelt.
- 3. COSEWIC = Committee on the Status of Endangered Wildlife in Canada.
- 4. OBBA = Ontario Breeding Bird Atlas. The Atlas is a multi-year survey undertaken by trained volunteers across Ontario to determine the distribution of breeding birds in the province. The most recent Atlas survey was undertaken in 2001-2005 (BSC, 2006).
- 5. NHIC = Natural Heritage Information Centre, the provincial repository for rare species occurrence data and other natural heritage information.
