Public Engagement Feedback Report

McBean Street Traffic Calming Study

Background

The City's Neighbourhood Traffic Calming (NTC) Program received complaints from residents about speeding along McBean Street. As a result, this street was reviewed by collecting and analyzing speed and traffic volume data. The results from the traffic survey concluded that McBean Street between Perth Street and Strachan Street met the criteria for a future traffic calming study to be initiated.

The study request was then added to the City's prioritization list of candidate traffic calming studies. In the fall of 2024, the study moved to the top of the prioritization list and was initiated. Based on traffic data, coordination with various stakeholders, and project constraints, a proposed concept plan has been developed.

The McBean Street NTC plan includes:

- McBean Street between Perth Street and Strachan Street
 - 3 speed cushions. Speed cushions are being proposed along this section of the street because it is an OC Transpo route and a key emergency response route for Fire Services. Speed cushions allow large vehicles like buses and emergency response vehicles to straddle the cushions.
 - Curb extensions (bulb-outs) on the north-west and south-east corners of McBean Street and Christopher Hamilton Street, Martin Street, and Strachan Street.
 - Edgelines.


Public Consultation and Online Survey Results

Over the summer of 2025, an online survey was conducted to gather feedback on the proposed traffic calming plan. The following section includes the results from the online survey and summaries of the individual comments received. A total of 255 people completed the online survey. The online survey was available from June 13th to August 11th, 2025.








