Independent Auditor’s Report

To the Ministry of Municipal Affairs and Housing and
To the City Clerk at the City of Ottawa (Elections Office)

We have audited the accompanying Financial Statement – From 4 and supporting schedules (the Financial Statement) of Mr. Jevone Nicholas, City Councillor Candidate for the June 30, 2015. The Financial Statement has been prepared by the Candidate based on the financial reporting provisions of Section 78 of the Municipal Elections Act, 1996.

Management’s Responsibility for the financial Statement

The Candidate is responsible for the preparation and fair presentation of this Financial Statement in accordance with the financial reporting provisions of Section 78 of the Municipal Elections Act, 1996 and for such internal controls as the Candidate determines is necessary to enable the preparation of a Financial Statement that is free from material misstatement, whether due to fraud or error.

Auditor’s Responsibility

Our responsibility is to express an opinion on this Financial Statement based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Financial Statement is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Financial Statement. The procedures selected depend on the auditors’ judgment, including the assessment of the risks of material misstatement of the Financial Statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal controls relevant to the entity’s preparation and fair presentation of the Financial Statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity’s internal controls. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Financial Statement.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for Qualified Opinion

Income from contributions is accounted for in the Statement of Campaign Income and Expenses, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of this income was limited to the amounts recorded in the records of the Candidate's campaign. Therefore, we were not able to determine whether any adjustments might be necessary to income and deficit for the campaign period from March 28, 2014 to June 30, 2015.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, this Financial Statement – Form 4 and supporting schedules present fairly, in all material respects, the income and expenses of Mr. Jevone Nicholas, City Councillor Candidate for the Rideau-Rockcliffe Ward 13 for the campaign period from March 28, 2014 to June 30, 2015 in accordance with the financial reporting provision of Section 78 of the Municipal Elections Act, 1996.

Basis of Accounting

The Financial Statement is prepared to assist Mr. Jevone Nicholas, City Councillor Candidate for the Rideau-Rockcliffe Ward 13, to meet the requirements of the Municipal Elections Act, 1996. As a result, the Financial Statement may not be suitable for another purpose.

Other Matter

In accordance with By-Law #2005-505 of the City of Ottawa, we confirm that we have verified all contributions against a bank statement for the campaign account.

Subsequent Event

Without modifying our audit opinion, we wish to draw attention that the Form 4 initially dated March 11, 2015 was modified on September 21, 2015, in order to reflect changes in the total amount of contributions received and other expenses. The total amount of contributions (income) was initially reported at \$12,235.33, and was modified to \$12,899.95. The total amount of office expenses incurred after voting day was initially reported at \$2.83, and was modified to \$12.44, the total amount of bank charges incurred after voting day office was initially reported at \$9.90, and was modified to \$44.55 and finally the deficit for the campaign, was modified from \$676.88 to a deficit of \$56.52.

We therefore issue a new independent auditor's report dated September 21, 2015, which replaces the initial report dated March 11, 2015, in order to take into account this

subsequent event. The audit procedures undertaken on the event following March 11, 2015 were limited to the above-mentioned matter.
