I have verified all contributions against the bank statement for the Jim Watson Campaign account and have audited the Statement of Campaign Income and Expenses and the calculation of Surplus or Deficit of Jim Watson, Candidate, for the campaign period from March 24, 2-14 to December 31, 2014 relating to the election held on October 27, 2014.

Candidate’s Responsibility for the Financial Statements

The Candidate is responsible for the preparation of these financial statements in accordance with the Municipal Election Act, 1996 and for such internal control as the Candidate determines is necessary to enable the preparation of financial statement that are free from material misstatement, whether due to fraud or error.

Auditor’s Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. These standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditors’ judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error.
