			Goal is to identify a second ranked Proponent in the event that the First Negotiations Proponent ("FNP") negotiations do not lead to Preferred Proponent ("PP") and to ensure tension associated with a second ranked Proponent during the FNP negotiations phase.
			Given that Technical Evaluations are ongoing, need to evaluate all bids as First Negotiations Proponent may not meet the minimum scoring thresholds to be considered for a total score.  Contemporaneous ranking of non-
			<ul> <li>Contemporaneous ranking of non- affordable bids with the affordable bid will promote consistency of financial scoring.</li> </ul>
