Canada Community-Building Fund

The <u>Canada Community-Building Fund</u> (CCBF), formerly the Gas Tax Fund, invests over \$2 billion each year to Canadian municipalities; Ontario's share is over \$800 million. Funds are distributed to communities across the province on a per-capita basis.

The CCBF is a permanent source of Federal funding for local infrastructure, providing funds to communities twice a year. First established in 2005, the CCBF has continually evolved to meet the needs of municipalities and their critical infrastructure projects. Funds can be invested across 18 project categories to address local priorities, promote economic growth, strengthen communities, and improve the environment.

Since 2005, the City of Ottawa has received \$939.7 million from the CCBF with an additional \$12.3 million earned in interest. Thanks to the CCBF the City of Ottawa has been able to invest over \$831.7 million into capital projects and debt servicing. The City of Ottawa has dedicated these funds to Transit Services projects, including bus purchases, transit corridors, Zero-Emission Buses, Light Rail and other critical transit infrastructure needs. The City received a one-time top up of \$58.48 million in 2019 that has been invested in Roads Resurfacing projects over the past three years.
